## CONDITIONS – FIRST BUS

- 1a. **Commercial Services:** Available for use on all commercial services within the area specified on the front of the ticket, with the exception of service X30 unless prior authority has been given by First. Unlimited use Monday to Friday **and at weekends** during term time only.  
**OR**
- 1b. **Yellow School Buses:** Available for **ONE RETURN** journey on Mondays to Fridays (unless otherwise endorsed) during normal term (not during school holidays) for journeys to and from school **BETWEEN POINTS STATED** and **BY THE MOST DIRECT ROUTE**. Also valid on other FirstGroup Company services between the points stated overleaf.
2. This ticket is valid for one inward journey on the first day of the **NEW TERM** following the last available date shown on the front of the ticket and must be surrendered thereafter.
3. This ticket **IS NOT TRANSFERABLE** and must always be produced for inspection and accompanied with a Photocard.
4. Ordinary fares are payable and will not be refunded if:
  - (a) the ticket has been withdrawn due to being mutilated or defaced.
  - (b) the ticket has been lost or damaged.
  - (c) the ticket was not presented at the time of travel.
5. Any misuses of the ticket renders the holder liable to **PROSECUTION**.
6. Not valid for journeys starting after 20.00 hours, unless otherwise authorised.
7. Lost or stolen tickets/photocards are replaced at the discretion of the operating company; an administration charge of £15\* will be payable.

Refunds: If you wish to surrender this ticket, eg because you are moving away, it must be returned to the Consortium Transport Office and the refund will only be calculated from the date of receipt at that office. Please note that termly tickets are sold at a discount and hence any refund will be calculated by applying a daily price to the number of school days elapsed. The refund will not therefore be pro-rata to the total price and the elapsed period of use. There is also a £5\* administration fee for processing any refund application.
